RESOLUTION NO: 15-TM-21

BE IT RESOLVED BY THE TE-MOAK TRIBAL COUNCIL OF THE TE-MOAK TRIBE OF WESTERN SHOSHONE INDIANS OF NEVADA; THAT

WHEREAS, this organization is a recognized Indian Organization as defined under the Indian Reorganization Act of 1934, as amended, and exercises rights of home rule and is responsible for the promotion of the economic and social welfare and well being of its members, **and**

WHEREAS, the Te-Moak Tribe is composed of four (4) constituent Bands, Elko, Battle Mountain, South Fork and Wells and is the parent council of said Bands, **and**

WHEREAS, the Constitution of the Te-Moak Tribe of Western Shoshone Indians of Nevada establishes Regular Band Tribal Council Elections; **and**

WHEREAS, the Election Procedures Ordinance, 03-ORD-TM-01, Section 13-4-2., provides that the Tribal Council adopt, by Resolution, a specific date for the Regular Band Council Election to be held the second week in October; **and**

WHEREAS, the Constitution Article 7- Election, Sec. 3- Tribal Chairperson Election and the Election Procedures Ordinance, 03-ORD-TM-01, Section 13-4-2.3 provides that the Tribal Council acknowledge the Tribal Chairman Election be 14 days after the selected Band Councils; **and**

WHEREAS, the Tribal Chairman Election shall be held according to Article 7, Sec. 3 Tribal Chairperson Election, within twenty-one (21) days after the Band Elections.

NOW THEREFORE BE IT RESOLVED, in accordance to the Constitution of the Te-Moak Tribe and Election Procedure Ordinance, the Tribal Council for the Te-Moak Tribe of Western Shoshone hereby sets **October 13, 2015** as the day for the regular, tribal-wide Band Council elections;



FINALLY BE IT RESOLVED, the Tribal Chairman election date is hereby set for **November 3 , 2015.**
